

1. We have reviewed the accompanying statement of unaudited Ind AS financial results of **Himadri Credit & Finance Limited** ("the Company") for the quarter ended 31st December, 2023 ("Statement") and year to date from 1st April, 2023 to 31st December, 2023 ("Statement").
